Destroying communi

MY CONSTITUENT Vivienne Westwood is a long-term resident of Clapham and has always taken a close interest in the local area.

It was rather shocking to see her attacked by Cllr Pete Robbins in your report of the protest about Lambeth selling the homes of long-term residents ("I'm a celebrity, don't sell off housing", South London Press. March 7).

I can only assume that he is feeling defensive about the policy. As a Labour MP, I believe in everyone having their say whatever their background or job and Vivienne has as much right to speak out as anyone.

Maybe Cllr Robbins could explain why Freedom of Information requests asking to see evidence of where the money from the sales has gone have been denied. He speaks of homes that COULD be built, not WILL be built, and he confuses affordable housing with social housing. His point about English Heritage listings

must be countered by the fact that co-ops had a role to play in keeping these houses standing in the first place, despite Lambeth's wilful neglect.

Furthermore, the eviction policy has allowed developers to destroy original features of the homes sold. Local co-op residents have complained bitterly about this, but the council have ignored them.

Lambeth still could engage constructively and allow these residents to become tenants. They have paid rent all their lives to their co-ops and did the council a favour by taking the homes on when Lambeth's redevelopment plans were abandoned back in the 70s and 80s. Instead, a short-term policy of selling off

is destroying mixed communities.

Once sold, they will never be replaced and the special nature of our inner city communities is lost for ever.

He says the houses are dilapidated Victorian English Heritage listed buildings. Lambeth council abandoned these houses decades ago. They were rescued from demolition by The Clapham Society in the first place, and subsequently the housing co-op communities restored and maintained them. The council should be thanking these people for the fact that they still have these

buildings at all! He says that hundreds of thousands of public money needs to be spent on these houses to turn them into council housing. He and Lib Peck have consistently refused to engage with the plan that Lambeth United Housing Cooperative have brought to them - a plan which has the backing of respected social housing experts and the Clapham Society amongst others, a plan which would not cost the council a single penny and which would improve the houses and enable them to remain council-owned houses occupied by council tenants!

Money struggles of those with HIV

MORE than 15 years after modern antiretroviral medication transformed HIV into a manageable

condition, Terrence Higgins Trust's new report HIV & Poverty (www.tht.org.uk/poverty) reveals a shocking picture of financial hardship among people with HIV in the UK.

The charity has seen a 15 per cent increase in people accessing its hardship fund, which helps people with HIV in severe financial need cover basic living costs, including food, clothing and heating costs. As the full impact of the

Government's welfare reforms starts to be felt, it is vital that our council [Lewisham] considers the needs of local people with HIV in its plans, and that financial, social and emotional

support is available for those whose condition affects their ability to work and maintain financial stability.



HIV and poverty should not be linked. But, without adequate support, financial stress, poor diet, and other factors associated with poverty can lead to mental and physical ill health for people with HIV, in turn making it harder for them to re-enter employment or regain financial control. Building homes with a purpose

I WRITE in reply to Cllr Anood Al-Samerai (Letters, March 7). Dealing with her points:

First, "People should live where they grew

up" – this Labour council changed the previous Lib Dem housing allocations policy of six months' residential qualification to one where residents with five years' residence or more get a priority. Second, "There should be

affordable homes in every new development" – this Labour council inherited the Heygate estate redevelopment without a commitment from the Lib Dems to build a single property of affordable rent and now Labour has signed a regeneration deal on the Aylesbury estate with 50 per cent affordable properties (with 75 per cent of that social rents). Third, "Stop the mass sell-off of council housing" - the Lib Dems sold off or demolished nearly 9,000 council homes between 2002-2010 – over 1,000 a year – while Labour has only sold 138 properties since 2010.

Fourth, "Replace Right to Buy sales" - the current Lib Dem coalition government is offering a discount of £100,000 to tenants to buy their own properties and applications in Southwark are now running at 22 per week.

This is why this Labour council will build 11,000 new council homes over the next 30 years with 200 already being built and sites for 500 more identified.
